Notice of Decision Not to Cancel under section s116 (General Power) of the *Migration Act 1958*.

On 13 December 2012 you were notified of the intention to consider cancellation of your Student (Temporary) (class TU) Higher Education Sector (subclass 573) visa which was granted on 08 July 2010.

You replied in a letter dated 28 December 2012 . Your comments have been taken into account in making this decision.

I have decided that there is a ground(s) for cancellation of your visa under s116(1)(b) breach of condition - 8202 of the *Migration Act (1958)* which states that:

116. (1) Subject to subsections (2) and (3), the Minister may cancel a visa if he or she is satisfied that:

(b) its holder has not complied with a condition of the visa;
or because

Australian National University (ANU) [00120C] on 14 November 2012 certifies Mr WANG, for course Bachelor of Science (Lab + Non-lab Based), as not achieving satisfactory course progress for section 19 of the *Education Services for Overseas Students Act 2000* and standard 10 of the *National Code of Practice for Registration Authorities and Providers of Education and Training to Overseas Students (National Code 2007)*.
