**申请背景:**

**麦考瑞商科本科毕业，学生签证马上过期**

Lin 同学从麦考瑞大学的商科本科毕业后，想要先申请毕业生临时工作签证（485 visa），之后再规划自己澳洲移民的道路。可是当时的 Lin 同学英文成绩还未达到 485 签证的申请要求。眼看着自己的学生签证马上就要过期了，着急的 Lin 同学在朋友的推荐下，慕名找到了哥伦布澳洲咨询，想要求助哥伦布资深的留学顾问和移民代理帮自己顺利留在澳洲。

### 成功拿到澳洲永居移民

在听取瑞斯律师的建议后，Lin 同学选择当场与哥伦布继续签约，由瑞斯律师亲自处理 Lin 同学的新州 190 签证申请。同时，Lin 同学的留学顾问胡老师，在两天内帮 Lin 同学拿到了 NAATI 学校的录取通知书，三天内帮 Lin 同学拿到职业年学校的录取通知书。

在资深移民律师瑞斯律师和资深留学顾问胡老师的帮助下，Lin 同学最终达到了新州 190 签证邀请的所有条件。瑞斯律师亲自为 Lin 同学撰写并递交移民申请意向申请（EOI）。果然，一切都在瑞斯律师意料之中，Lin 同学成功拿到新州 190 签证邀请，并在第二年的年初，成功拿到了澳洲永居签证！
