## Decision

I am a delegated decision maker under section 65 of the *Migration Act 1958* (the Act). In reaching my decision, I have considered relevant legislation contained in the Act and the *Migration Regulations 1994* and information contained in the department's policy guidelines *Procedures Advice Manual 3*.

Under the migration law, a visa cannot be granted unless the applicant meets the relevant legal requirements that are specified in the Act and the Regulations. Your application has been considered against the criteria for a subclass 600 visa in the Visitor visa class.

As you do not meet one or more clauses in Schedule 2 of the Regulations, I find that you do not meet the criteria for the grant of a subclass 600 visa in the Visitor visa class. Therefore, I refuse your application for a Visitor visa.
